RE RESTRICTED FILING STATUS RE DARRYL ROBINSON, MDOC # 172898 Administrative Order No. 18-MS-086

BACKGROUND

Case No. 1:08-CV-353, Robinson v. Mawer

The Clerk of Court recently received a submission from Darryl Robinson, MDOC # 172898. A copy of the submission is attached as Exhibit A. The first page of the submission purports to be a Notice of Appeal in Case No. 1:08-CV-353, a prisoner civil rights case originally dismissed over eight years ago, on June 11, 2008. Since that time, Mr. Robinson has filed seven previous appeals in the case, each without success. An eighth appeal is currently pending. This new one would be the ninth.

On January 12, 2017, the Court of Appeals not only dismissed an earlier appeal, but also imposed sanctions designed to deter future filings. The new submission is Mr. Robinson's fourth purported Notice of Appeal in the case since the sanctions Order. This new Notice of Appeal not only runs afoul of the sanctions Order, it is also eight years late and facially deficient for failing to name the particular Court of Appeals to which Mr. Robinson is appealing, or the particular Order or Judgment being appealed. But none of this has relieved the administrative burden of either this Court or the Court of Appeals.

PATTERN OF ABUSIVE FILINGS

The latest submission follows a well-established pattern of abusive filings by Mr. Robinson that needlessly consume the resources of both the District Court and the Court of Appeals. The most recent submission (Exhibit A) includes not just the page-one purported Notice of Appeal in Case No. 1:08-CV-353, but also 72 additional pages, each purporting to be a Notice of Appeal in some other long-closed case originally filed by Mr. Robinson. Moreover, because Mr. Robinson is serving a life sentence imposed by the State of Michigan, the prospect for ongoing abusive filings is high.

Mr. Robinson has filed a total of 80 civil cases in the Western District of Michigan from 1989 through 2017. (See Exhibit B) None are currently open. Most close quickly because Mr. Robinson is unable to cure deficiencies or survive screening. In fact, he already has 50 cases on the "Three Strikes" list (Exhibit C), making him generally ineligible to file new Prisoner Civil Rights cases without paying the full filing fee.

The statutory "Three Strikes" process protects both the administrative resources of the Court and Mr. Robinson's First Amendment rights with respect to new cases. But it does not help on the pattern of abusive Notices of Appeal. In addition to the newly submitted purported Notices of Appeal in 73 separate cases (the Exhibit A submission, with the list of cases summarized at Exhibit D), Mr. Robinson has filed 134 other purported Notices of Appeal—a total of 207 such filings, each requiring significant administrative time and postal expenses by both the District Court and the Court of Appeals.

The purpose of this Administrative Order is to provide a method for the Court to defend its administrative resources against abusive purported Notices of Appeal without impairing Mr. Robinson's First Amendment rights to seek relief in appropriate ways.

RESTRICTED FILING ORDER

The Court of Appeals has repeatedly tried to curb the abusive filings, albeit without success.

(Exhibit E) This Court has been cautious to reject only those past Notices of Appeal that are facially

deficient. (Exhibit F) Because the most recent submission of 73 new purported Notices includes

facial deficiencies, the Court could simply reject this batch of notices. However, in light of the

abusive history detailed here, the inability of prior sanctions to curb the abuse, and prospect of

ongoing abuse, the Court must do more than simply reject the most recent submission of 73

purported Notices of Appeal.

Accordingly, the Court issues this standing Administrative Order directing the Clerk of Court

to reject any future submission of any kind, including without limitation any purported Notice of

Appeal, from Mr. Robinson in any of the 80 civil cases previously filed in and dismissed by this

Court. The list of affected case is collected at Exhibit B. As that list notes, the most recent of these

cases was closed March 20, 2018 (Case No. 2:17-CV-146), and the Court of Appeals has already

dismissed Mr. Robinson's appeal in that case.

This court entered an order directing Darryl A. Robinson to show cause why appeal No. 11-1270 should not be dismissed on the basis of a late notice of appeal. The order also advised Robinson that this court in *Robinson v. Wertanen*, No. 09-1109 (6th Cir. May 11, 2009), warned him that he may be subject to sanctions if he filed future appeals which "are clearly late, a second appeal from the same decision of the district court, or an appeal taken to this court seeking review of a prior decision of this court." The show cause order entered in this appeal also directed Robinson to show cause why sanctions should not be imposed against him for this late appeal. Robinson responded by stating that his appeal is late because he is not an attorney, he was in segregation, and he does not know what he is doing. He asks this court for appointment of counsel.

It appears from the documents before the court that the district court entered its judgment on October 12, 2005. This court on May 11, 2009, dismissed as late Robinson's January 14, 2009 notice of appeal, and warned Robinson that sanctions may be imposed if he filed future appeals which were late or duplicate appeals (appeal No. 09-1109).

On January 25, 2011, this court received a notice of appeal from Robinson, and forwarded that notice of appeal to the district court for filing as provided by Federal Rule of Appellate Procedure 4(d). The January 25, 2011 notice of appeal sought to appeal "from United District Court for the Western District of Michigan entered in this action in the 25 day of August, 05." No order was filed or entered in the district court on August 25, 2005, thus it is assumed that the appeal was taken from the October 12, 2005 judgment dismissing the August 25, 2005 complaint. The January 25, 2011 notice of appeal filed more than five years after entry of the judgment is late. *See* Fed. R. App. 4(a) and 26(a). Moreover, it is a duplicate to appeal No. 09-1109 which this court dismissed in 2009, and in which this court warned Robinson of the possibility of sanctions being imposed if he continued to file late appeals and duplicate appeals.

Compliance with Federal Rule of Appellate Procedure 4(a) is a mandatory prerequisite that this court may neither waive nor extend. *Budinich v. Becton Dickinson & Co.*, 486 U.S. 196, 203 (1988); *Ultimate Appliance CC v. Kirby Co.*, 601 F.3d 414, 415-16 (6th Cir. 2010). Federal Rule of Appellate Procedure 26(b) specifically provides that this court may not enlarge the time for filing a notice of appeal except as authorized in Rule 4.

Robinson was warned in *Robinson v. Wertanen*, No. 09-1109 (6th Cir. May 11, 2009) that he may be sanctioned if he filed future appeals which were "clearly late, a second appeal from the same decision of the district court, or an appeal taken to this court seeking review of a prior decision of this court." Appeal No. 11-1270 is both a notice of appeal filed clearly beyond the thirty-day appeal period provided by Federal Rule of Appellate Procedure 4(a), and a duplicate appeal to appeal No. 09-1109. Since this court's 2009 warning, Robinson has continued to file defective appeals. Six late appeals were dismissed in 2010, and several more defective appeals have already been dismissed in 2011.

It is ordered that appeal No. 11-1270 is dismissed, and the request for appointment of counsel is denied.

It is further ordered that sanctions be imposed against Robinson. Robinson is denied leave to proceed in forma pauperis on appeal in any future appeal he may file in this case. If he chooses

to file a subsequent notice of appeal in this case, he must pay the appellate filing fee in full prior to the appeal being permitted to proceed in this court. Failure to pay the required appellate filing fee will result in dismissal of the appeal.

This matter is before the court upon initial consideration of appellate jurisdiction. The district court entered its judgment on October 28, 2005. Darryl A. Robinson appealed on January 14, 2009 (appeal No. 09-1110), and this court dismissed the appeal on May 12, 2009 as untimely. Robinson filed a second notice of appeal on August 14, 2015 (appeal No. 15-1982), and this court dismissed the appeal on October 7, 2015. Robinson filed a third notice of appeal on April 1, 2016 (appeal No. 16-1418), and this court dismissed the appeal on June 14, 2016. Robinson filed a fourth notice of appeal on November 14, 2016 (appeal No. 16-2626, the current appeal). The November 14, 2016 notice of appeal is over ten years late, and it appears to be a duplicate of appeal No. 09-1110. See Fed. R. App. P. 4(a), 26(a).

Compliance with Federal Rule of Appellate Procedure 4(a) is a mandatory prerequisite that this court may neither waive nor extend. *Bowles v. Russell*, 551 U.S. 205, 214 (2007); *Ultimate Appliance CC v. Kirby Co.*, 601 F.3d 414, 415-16 (6th Cir. 2010). Federal Rule of Appellate Procedure 26(b) specifically provides that the time for filing a notice of appeal may

not be extended except as authorized in Rule 4. We have reviewed the record and find that the exception authorized by Rule 4 does not apply in this case.

Robinson was warned in *Robinson v. Kutchie*, No. 09-1110 (6th Cir. May 12, 2009), that he may be sanctioned if he filed future appeals that were "clearly late, a second appeal from the same decision of the district court, or an appeal taken to this court seeking review of a prior decision of this court." Appeal No. 16-2626 is both a notice of appeal filed clearly beyond the thirty-day appeal period provided by Federal Rule of Appellate Procedure 4(a) and a duplicate of appeal No. 09-1110.

It is ordered that appeal No. 16-2626 is **DISMISSED**.

It is further ordered that sanctions be imposed against Robinson. Robinson is denied leave to proceed in forma pauperis on appeal in any future appeal he may file in this case. If he chooses to file a subsequent notice of appeal in this case, he must pay the appellate filing fee in full before the appeal will be permitted to proceed in this court. Failure to pay the required appellate filing fee will result in dismissal of the appeal.
