assigned to Judge Jonker and Magistrate Judge Green.

IT IS FURTHER ORDERED that another case(s) shall be assigned to Judges Jarbou and

Maloney, as appropriate, according to the approved procedure.

as any future case assigned to Judge Jonker under this order.
